Online tag renewal:

The vendor charges a non-refundable convenience fee to process payments.

There is a **\$2.25** convenience fee when using a debit card and a **2.25%** convenience fee for all credit card payments. There is a \$75,000 limit when using online services:

Forms of Payment

We accept cash, money orders, checks, debit and credit cards. **Decals/plates paid for by check will be mailed out after 10 business days.** However, you will be given a copy of your registration at the time of purchase.

Change of address:

You must contact our office to update your mailing address for your vehicle registration; this change can not be completed online.

Recently moved into the State?

You have 30 days of moving into the state to register your vehicle. If not registered within 30 days a \$250 fee will be added to your registration.

Penalty fees for late registration:

You have 7 working days of your in-state purchase date to register your vehicle. If you purchase out of state, you have 7 working days plus 2 additional days to register your vehicle. In this case, the penalty will apply on the 10th day. You will stay in 5% penalty for 15 days, on the 16th day there will a 10% penalty applied, each subsequent 30 days period after then an additional 15% will be applied. After another 30 days period an additional 20% will be applied, up to 25%. Once you have reached 25% penalty your Legislative Tag Credit is lost.

Penalty fees for late renewals:

You will be given an additional 15 days to register your vehicle after your Expiration month. On the 16th day a five percent penalty will be applied. You will stay in 5% penalty for 15 days, on the 16th day there will a 10% penalty applied, each subsequent 30 days period after then an additional 15% will be applied. After another 30 days period an additional 20% will be applied, up to 25%. Once you have reached 25% penalty your Legislative Tag Credit is lost.

Reminders:

*Vehicle registration renewal cards are mailed as a courtesy reminder. *It remains your responsibility to renew your vehicle registration if the reminder card is not received.*

*The Tax Collector's office is not responsible for any items once they are mailed out of the office.

***Please make sure to verify your address during all transactions and notify us of mailing address changes for vehicle registrations only at 601-968-6588.**

* Check the website or call our office for accurate payment amounts after interest has been added for late renewals or property tax payments. This will eliminate having your check returned due to incorrect payment amounts.

Mobile Home Information

Mobile homes that are registered as personal property will be entered in the Hinds County Tax Collector's billing file. Mobile home taxes are due the 1st year, 90 days after the registration date. The 1st year taxes are prorated from the registration date to the end of the calendar year. Thereafter, taxes are due and payable annually. A civil suit may be filed to collect unpaid mobile home taxes that are 90 days overdue.

If, at any time, you sell or move your mobile home from its current location, please notify Alexis Nelson (Tax Collector's office in Raymond) at 601-857-5574. You will be asked for proof of sale of the mobile home before it will be removed from the tax roll.

Taxes

All homeowners received a courtesy real estate property tax notice. Please keep for your records. If you have an escrow account, your mortgage company will submit payment on your behalf.

If your mortgage is paid in full or you do not have an escrow account, you are responsible for the amount due on the courtesy card. You can pay in installments. The first installment is due by Feb. 1 and is 1/2 of the total amount due. The remaining balance can be paid in two equal payments. Interest accrues after February 1st and every 30 days until the balance is paid in full.
